1. The Government of Nepal has received a grant from the Asian Development Bank (ADB) for Capital Market & Infrastructure Capacity Support Project. Part of this grant will be used for payments under the contract named above.
2. The Ministry of Finance, Government of Nepal (“the Employer”) invites sealed bids from eligible Bidders for:
 - a. Study, Design, Development, Implementation, Go-Live and warranty support of Debt Operation & Management Software (DOMS) which will include three modules namely
 - (i) Debt Recording and Accounting Module,
 - (ii) Online Bidding and Auction Module and
 - (iii) Clearing and Settlement Moduleand should meet the technical, functional and business requirements as mentioned in this bidding document, but not limited to the same and
 - b. Supply, Installation and Commissioning of Middleware, Database and other system software as required for DOMS
 - c. Preparing the Bill of Material (BOM) and technical specification for ICT Infrastructure required for running DOMS and monitoring & supervision of the Supply, Installation, Testing, Commissioning and systems integration of the said ICT infrastructure
3. International Competitive Bidding will be conducted in accordance with ADB’s ‘*Single-Stage: Two Envelope*’ Bidding Procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

 - ii. pay a non-refundable fee of NPR 6,000.00 (Nepalese Rupee Six Thousand Only) or USD 60.00 (US Dollar Sixty only) by cash/cashier’s check in favor of Ministry of Finance. If the Bidder desires to have the Bidding Document sent to him by courier to an address outside Kathmandu, the Bidder shall pay an additional amount of NPR 25,000.00 (Nepalese Rupee Twenty-five thousand only) or USD 250.00 (US Dollar Two hundred fifty only) for cost of courier at the time of making the application.
