If the local agent of the Bidder wishes to purchase the Bidding Document on behalf of the Bidder, such agent shall submit an authorization letter from the concerned Bidder along with attested copies of its Firm Registration Certificate and Permanent Account Number (PAN) Registration Certificate. If so requested, the Bidding Documents can also be sent by courier services/post upon payment of additional cost of NRs. 3,000.00 (Three Thousand Nepalese Rupees) or USD 28.00 (Twenty Eight US Dollars). However, the office will not be responsible for delay or non-delivery of the documents so sent.

- 7. Sealed Bids must be submitted to the address mentioned above on or before 14:00 hours, March 13, 2016. Bids received after this deadline shall not be accepted.

Bids must be valid for a period of one hundred twenty (120) days counting from the day of bid opening and must be accompanied by bid security, amounting to Nepalese Rupees 2,700,000.00 or USD 25,000.00 as specified in the bid data sheet, which shall be valid for minimum 30 days beyond the bid validity period (i.e. August 09, 2016)
- 9. Bids shall be opened in the presence of Bidders' or their authorized representatives who choose to attend at the address mentioned above at 15:00 hours, March 13, 2016.
- 10. If the last date of purchasing, pre bid meeting, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
